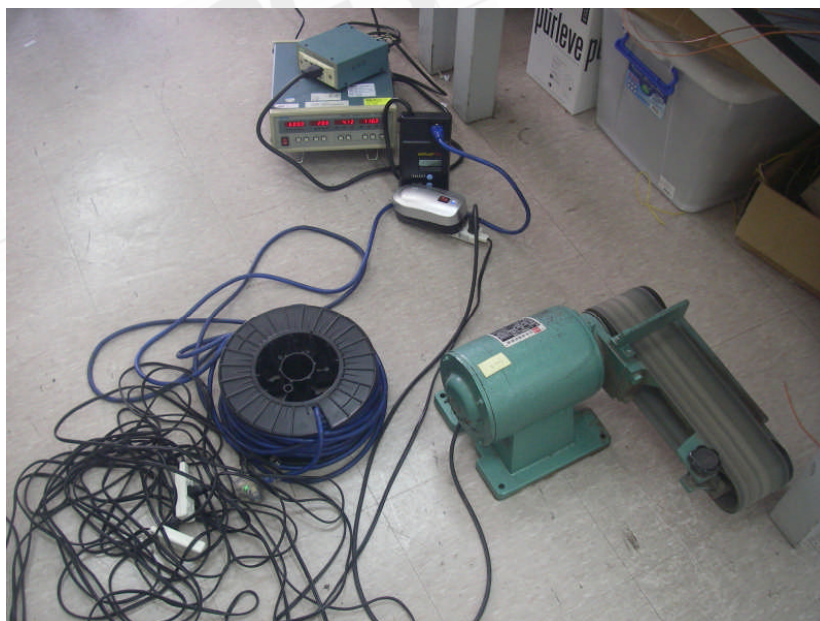

**Test method:**

Connect the wheel motor to the Mega Power Saver in parallel and power the motor with 110Vac, 60Hz. Run the motor with the Mega Power Saver in off position for 5 hours continuously then record the current and power consumption. Turn the Mega Power Saver on and run the motor for another 5 hours then record the current and power consumption.
